

## INDEX

This index is constructed for the use of key words to find applicable sections. For example, to find information about *off premises signs*, find the key word *sign* and then proceed to *off premises* under the sign heading; or, to find the required setbacks for *nonconforming uses*, find the key word *nonconforming*, and then find *setbacks*.

References are to section designation rather than page numbers to facilitate updating the index when changes are made to the ordinance. As sections are added to the ordinance the page numbering will change; however the base section numbering will not.
